Practical Arrangements

These Practical Arrangements are made between the International Atomic Energy Agency (hereinafter referred to as the “IAEA”) and the International Union of Radioecologists (hereinafter referred to as the “IUR”).

1. In order to enhance the relationship between IUR and the IAEA, IUR and the IAEA have reached an understanding on the following modalities of cooperation:

- Exchange and dissemination of information within the framework of the IAEA’s project on Environmental Modelling for Radiation Safety (EMRAS II), including joint publications;
- Collaboration within the framework of the EMRAS II project, in particular EMRAS II Working Group 5 on “Wildlife transfer coefficient handbook” and EMRAS II Working Group 6 on “Biota dose effects modelling – Multiple Stressors”.

2. IUR and the IAEA will each appoint a focal point responsible for the coordination of activities under these Practical Arrangements.

3. IUR and the IAEA will consult annually, or as practicable, on the cooperation activities to be carried out under these Practical Arrangements.

4. IUR and the IAEA will support the widest possible dissemination of unclassified information provided or exchanged under these Practical Arrangements, subject to the need to protect proprietary information. IUR and the IAEA will ensure confidentiality of the information classified by the other party as restricted or confidential.


5. IUR and the IAEA will cooperate to ensure that the intellectual property and rights thereto, including, without limitation, all copyrights and patents, in and to any material or invention produced by either party, their employees and sub-contractors arising from the cooperation between IUR and the IAEA in the implementation of these Practical Arrangements can be used to further the IAEA statutory function of, *inter alia*, fostering the exchange of information among its Member States, as well as to strengthen the IUR worldwide role of networking radioecological activities and scientists.


6. Nothing in these Practical Arrangements gives rise to legal or financial obligations upon either party. To the extent any activity may give rise to a legal or financial obligation, a separate agreement shall be concluded subject to the IAEA’s Financial Regulations and Rules, prior to such activity being undertaken.

7. Any disputes arising out of or relating to interpretation or implementation of these Practical Arrangements will be amicably settled among the parties.

8. Nothing in these Practical Arrangements shall be construed as a waiver of the privileges and immunities accorded to the IAEA by its Member States.

9. Either party may terminate these Practical Arrangements by giving sixty (60) days written notice to the other party. Where notice of termination is given, the parties shall take immediate steps to bring all joint activities to a close in a prompt and orderly manner.
